ORDER:

For the academic year 2013-14, the University has granted certain concessions in the credit based promotion rules for the B.Tech./B.Pharm. students (vide read.1).

Certain students have requested the University to extend the same concessions in the credit based promotion rules for the academic year 2014-15.

The Standing Committee for Academic Senate has considered the requisition and resolved to extend certain amendments in the credit based promotion rules of R09 regulations for the academic year 2014-15 (vide read.2). Accordingly, the orders with the following amendments are issued:
