#### ORDER:

The University has granted certain concessions in the credit based promotion rules for the B.Tech./B.Pharm. students for the academic year 2015-16 (vide read.1).

Certain students of R09 and R13 regulations of various affiliated colleges have requested the University to provide concessions in the credit based promotion rules for the academic year 2016-17.
