

Memorandum of Understanding between

GEETHANJALI INSTITUTE OF SCIENCE AND TECHNOLOGY,
GANGAVARAM, KOVUR, ANDHRA PRADESH
and
SAK INFORMATICS, HYDERABAD, TELANGANA

GEETHANJALI INSTITUTE OF SCIENCE AND TECHNOLOGY, GANGAVARAM, KOVUR, ANDHRA PRADESH and SAK INFORMATICS, HYDERABAD is esteemed institutions, and is signing up this Memorandum of Understanding (MoU) of collaboration and cooperation in education, research, and academic project work. The two institutions have long collaborated in research consortia and programs and have forged extensive personal and professional linkages. This history and its evolution led to the recognition of a shared future together that sets the stage for this MoU.

It is the intent of the direction of GEETHANJALI INSTITUTE OF SCIENCE AND TECHNOLOGY, GANGAVARAM, KOVUR, ANDHRA PRADESH and SAK INFORMATICS, HYDERABAD to foster and expand research, education, and cooperation between two institutions through this MoU. This document provides the general structure and principles to facilitate a relationship between the two institutions.

Mechanism for Foster Collaboration and Cooperation:

- SAK INFORMATICS was established in 2012 year for R&D, Product Development, Course Designing, Technology Training, Project Implementation, and Placement Guidance. We have registered under the section 58(1) of the Indian Partnership Act. 1932 and has been entered in the Register of Firms as No. 3286 of 2014 at Hyderabad (South).
- 2. SAK INFORMATICS will enhance the scientific, technical, and engineering competence of students from ECE branch of GEETHANJALI INSTITUTE OF SCIENCE AND TECHNOLOGY, GANGAVARAM, KOVUR, ANDHRA PRADESH by extending its support for design and execution of their academic project work, which is a part of their curriculum.
- SAK INFORMATICS extends its services for Software design assistance, Schematics design, documentation support and execution support for academic project work.
- 4. The funds required to execute the project works and other programs will be paid to SAK INFORMATICS via the management of GEETHANJALI INSTITUTE OF SCIENCE AND TECHNOLOGY, GANGAVARAM, KOVUR, ANDHRA PRADESH.
- The progress report of project work will be reported to the head of the department for continuous assessment and evaluation.

Commercials and Schedule:

- The quotation for these major projects with technology training will be INR 3300/- per student + Hardware cost extra (if any). The terms and conditions for the above said cost is as follows:
 - i. Technology training (i.e., Arduino with IoT, DIP, and VLSI) will be provided as a part of project training and then implementation will be done on selected project title.

- ii. The training duration for major projects will be 15 working Days.Benefits for the student/department/college:
 - 1. Trainers in SAK INFORMATICS will be able to guide and help the students towards the end of the project (whenever it is required).
 - SAK INFORMATICS will provide 41 publications in UGC CARE Group-2 (Scopus discontinued) journals.
 - 3. SAK INFORMATICS will provide 3 Indian Patent filing and publication.
 - 4. SAK INFORMATICS will also organize a Two-day National Workshop on Arduino with IoT for current 3rd Year ECE students.
 - 5. An E-certificate of project completion will be provided for individual students and each batch as well.

Payment terms:

- 1. All payments should be made by cash or RTGS fund transfer.
- 2. Payment schedule:
 - i. 1st instalment: 30% of the total fee should be paid after completion of the 6th day project training program.
 - 2nd instalment: 40% of the total fee should be paid after completion of the 12th day project training program.
 - iii. 3rd instalment: 30% of the total fee should be paid after completion of project training schedule with soft copies of documentation, codes, and any other related material to the project.
- 3. Payment should be on time as described above.

Validity:

This Memorandum shall commence from the date of its signing and shall continue for a period of one year from the date thereof and can be renewed for successive year on mutual understanding and acceptance.

- The Parties may establish a "Combined Functioning Group" to manage and execute the cooperative activities mentioned in this MoU.
- The Parties will endeavor to ensure that the Functioning Group is composed of the representatives of the Institutes, Organizations and Academic community related to the field of all the branches.
- Each Party will nominate appropriate personnel to discuss and promote detailed cooperation activities for the implementation of this MoU. When necessary and as mutually agreed, the Parties may hold working meetings. One Party shall notify the other Party of any modification in writing in case of change in the assigned personnel.
