After reviewing the information submitted by the department for the academic Session 2023-24 both semester and interacting with faculties of department the following observations are made by the team and requested to suggest action plan towards quality enhancement.

S.No	Items	Observations
1	Course file audit	1.CO Feedback form analysis is not found in few course files. 2. Topic beyond the syllabus evidences not found. 3. Gaps identification is not properly addressed for the courses.
2	Lab file audit	1. List of experiments including additional experiments and their CO, PO/PSO mapping is not available in few Lab files. 2. list of working models /photo types/products with proper documentation not available in few lab files.
3	Department audit	1. Research publications by faculties was poor 2. NPTEL course by faculty was not found 3. Number of FDPs conducted for faculty was poor
4	Student quality enhancement audit	1.NPTEL certifications for the students found to be very low 2. It has been found that all the students are not involved in workshops, symposiums, internships. 3. It has been found that remedial classes are not adequate.
5	Teaching methodologies audit	1. Less number of teaching methodologies are used by faculty. 2. Outcome of teaching methodologies is not mentioned
6	Project file audit	1.Rubrics of the project evaluation should be precisely defined. 2. papers to be published in good reputed journals.

Other Observations:

- The number of Research Projects of the department is lacking.
- The teaching according to the academic schedule is good.
- Class room teaching is supplemented with special lecture with eminent academicians, groups discussions, paper presentation by students, industrial visits.
- Drop out rate is low.
- Importance to be communication and soft skills classes found to be low.
- No visiting professors.

The academic performance of the department is required to be improved further. It may be recommended that the department should give emphasis on collecting funds for research projects as well as organizing seminars.
